ANTARES VISION EXPANDS INTO THE FAR EAST: NEW SALES BRANCH IN CHINA

The Board of Directors resolves the opening of a branch in China. The operation falls under the expansion strategy that strengthens the direct presence in the Far East market.

Travagliato (BS), 27 January 2020 – The Board of Directors of Antares Vision S.p.A. ("**Antares Vision**" or the "**Company**") has resolved today to initiate the procedures, by assigning the relevant powers to the Managing Directors, to open a new branch in China, in Shenzhen, 100% of which is held by Antares Vision APAC.

After setting up the Hong Kong branch in 2019, the decision to open a new branch in China aims at enhancing the business on the Chinese market, strengthening the Antares Vision hub on the Far East market. The decision is consistent with the "Made in China 2025" plan, launched in 2015 by the Chinese government to assure the technological leadership of the country's products. The governmental authorities have set out policies to assure and enhance the quality of products and to fight counterfeiting. The portfolio of solutions implemented by Antares Vision is undoubtedly interesting in this connection, also following the acquisition of FT SYSTEM, leader in inspection and testing solutions in the beverage sector. The priority of the pharmaceutical sector in the Chinese development plan is confirmed, and this is where the expertise and know-how of Antares Vision can make a difference in guaranteeing the quality of the products and fighting counterfeiting.

The Chinese branch is scheduled to open by this year. It will be a sales branch with the aim of strengthening and improving proximity on the Chinese market.
